The payment of Profession Tax of Rs. 1,07,300/- is outstanding as on March 31, 2022 which includes outstanding for the FY 2018-19, 2019-20, 2020-21 and 2021-22. The Profession Tax Returns are pending to be filed due to non-payment. There will be late fees of Rs 1,000/- p.a to $\frac{1}{2}$ be paid for delay in return for each year. The Company has collected VALUE ADDED TAX and as on March 31, 2022 Rs.6,40,352/ remain unpaid. The Company applied for VALUE ADDED TAX Registration Certificate several times, but due to some technical error & Website of Mahavat.gov.in is under maintenance/ updation continuously, Company could not able to get the same. Due to this, we are unable to quantify the Interest & Penalty for the VAT liability remaining unpaid
